Your purposes for studying *TRAGER* work and your intended use (personal or professional):

The *TRAGER* Professional Certification Program requires a *minimum* of 226 supervised hours classroom training and Tutorials plus a *minimum* 183 hours fieldwork (prerequisite sessions given and received), to a *minimum* total 409 hours. Average costs to complete the *TRAGER* International Certification Program to *TRAGER* Practitioner level are approximately \$5000 CAD plus Trager Canada Student Membership (see below).

Trager Canada Student Membership of \$60 CAD for 5 years.

Student registration in a Trager Canada Level I *TRAGER* training must be accompanied by a minimum deposit of \$250.

Students who cancel AFTER registration and BEFORE the first day of training may receive a full refund minus \$150.00 registration fee depending on the cancellation date. A Prorata refund may be given if the Student withdraws from the class before 60% of instruction completed. A full refund will be given if the Class Organizer cancels the training.

Student Pre-requisites: Prior to application for the Certification Program, the prospective Student must complete the following Minimum requirements:

- Receive at least 2 *TRAGER* sessions from a currently certified *TRAGER* Practitioner. You may substitute one session with an Introductory Workshop or 6 hours of *MENTASTICS*[®] classes.
- A written recommendation is required from your *TRAGER* practitioner or your Workshop Leader for you to apply for entry to the *TRAGER* professional certification program. This recommendation is not automatic. It may be suggested that you take additional sessions or workshops and assess your suitability for *TRAGER* professional training before reapplying for a recommendation.
